The supplied product is a multilayer protective packaging material based on polyethylene film manufactured by extrusion technology.

The product is intended for protection of goods against mechanical damage during handling, storage, and transportation.

The bubble wrap film is designed as a predominantly mono-material PE packaging product supporting material recycling.

Recyclability depends on the availability of local collection, sorting, and recycling systems for plastic films.

GLOBALFOL s.r.o. continuously monitors developments and implementation requirements related to the PPWR.
